After consultation with MCC leadership, Spark will be returning to in-person instruction next week. Though our teachers and students brought a great effort toward making our week of remote instruction effective, we welcome the opportunity to work with our students face-to-face.

With the current level of Covid spread, it will be most important that we follow our protocols without exception.


- Masks must be worn at all times with the exception of time outdoors and lunch when students may remove their masks to eat but must remain in their seats.
- 2. Distance must be maintained from others to the greatest extend possible in classes, hallways, etc.

There will be no exceptions to these rules. We all value inperson instruction. However, Covid spread within our school may

result in our having to move back to remote instruction. Students who fail to follow protocols completely will be required to remain at home until we have met with the family to make sure both the student and parents understand and fully agree to adhere to this policy.

The following is from the NH HHS site as of January 6, 2020:

- Students benefit from in-person learning, and safely returning to in-person instruction continues to be a priority.
- Vaccination is the leading public health prevention strategy to end the COVID-19 pandemic. Promoting vaccination can help schools safely return to in-person learning as well as extracurricular activities and sports.
- CDC recommends universal indoor masking by all* students (ages 2 years and older), staff, teachers, and visitors to K-12 schools, regardless of vaccination status.
- New CDC guidance has reduced the recommended time for isolation and quarantine periods to five days. For

- In addition to universal indoor masking, CDC recommends schools maintain at least 3 feet of physical distance between students within classrooms to reduce transmission risk. When it is not possible to maintain a physical distance of at least 3 feet, such as when schools cannot fully re-open while maintaining these distances, it is especially important to layer multiple prevention strategies, such as screening testing.
- Screening testing, ventilation, hand washing and respiratory etiquette, staying home when sick and getting tested, contact tracing in combination with quarantine and isolation, and cleaning and disinfection are also important layers of prevention to keep schools safe.



- Students, teachers, and staff should stay home when they have signs of any infectious illness and be referred to their healthcare provider for testing and care.
- This guidance emphasizes implementing layered prevention strategies to protect students, teachers, staff, visitors, and other members of their households and support in-person learning.
- Localities should monitor community transmission, vaccination coverage, screening testing, and occurrence of outbreaks to guide decisions on the level of layered prevention strategies (e.g., physical distancing, screening testing).
